You will be collaborating with Professor John Doebley working on statistical analysis of genomic data for teosinte, the wild ancestor of maize. It is expected that during your stay you will analyze genetic and genomic data for teosinte using ASREML, TASSEL and other software tools and prepare a manuscript for publication on the results of the analysis. The goal of this project is to analyze genetic and genomic data for five populations of the maize ancestor teosinte.




